Payment Guidelines

SOLE SPONSORSHIP: 50% deposit due upon agreement offer and signing. Remaining 50% due 30 days prior to event date. Catering, door prize and venue expenses (if any) are the responsibility of the sponsor, and are not paid by the Chamber.

GRAND SPONSORSHIP: 50% deposit due upon agreement offer and signing. Remaining 50% due 30 days prior to event date. Grand Sponsors maintain responsibility of selecting and securing event venue. The Chamber is responsible for food, beverage and door prize expenses up to \$750.

TRADE SPONSORSHIPS: For the protection and security of both parties, the Chamber will offer a contract agreement reflective of the traded services for accounting and scheduling purposes.

Cancellation Guidelines

In any case of cancellation after contract has been signed and event date has been scheduled/reserved, 50% deposit is non-refundable and non-transferrable.

Timeline

The Chamber will offer event contracts for each sponsored event on May 22. Signed contracts and deposits are to be returned by June 26th.
